Under instruction from and on behalf of my client Ms. _____ daughter of _____ residing at _____ I do hereby serve you with a notice, the contents of which are hereunder mentioned :-

1. That you were married to my client on date _____ at venue _____ according to Hindu rites and customs according to the Hindu Marriage Act, 1955 in the presence of family, friends and other relatives of both the parties.
2. That after the marriage you and my client were living together as husband and wife and cohabited on _____ and out of that wedlock one daughter of name _____ and age _____ was born.
3. That at the time of the wedding, my client's parents had given some valuable articles (detailed descriptions of articles are attached) as dowry to you and your family. At the time of the marriage you were indulged in unethical activities like consuming alcohol on daily basis and also gambling. You started adopting cruelty, first mentally and then physically upon my client and whenever my client tried to raise her voice against this, you and your family which included your unmarried sister beat my client mercilessly.
4. That your and your family's attitude was indifferent towards my client from the start of this marriage. You were always rude and my client always fulfilled your illegal demands from time to time. Your mother always taunted and shouted on my client and always told her to settle in the family and face all the atrocities.
5. That my client was of the view that after the birth of the daughter you and your family will mend your ways and start to behave and leave your bad habits but you and your family proved her wrong and never stopped to insult, abuse or maltreat her. Your mother pushed out my client from her matrimonial home several times.
6. That on _____ you beat my client and turned out her from her matrimonial home and also kept the daughter in your custody. You and your family from the day of _____ are blackmailing and abusing my client and her innocent family. You have refused to return the dowry items, jewellery of my client which she bought with her at the time of wedding. You

have deserted my client in every possible way and now after facing all this she is not interested in returning to that home. My client is also not interested in taking the custody of the minor child as she has been threatened by you and your mother that if she tries to take away the daughter you will cause her death.

7. Hence my client wants to dissolve the marriage immediately.
8. I, therefore, call upon you through this legal notice to serve a Divorce Deed within 15 days of receipt of this legal notice dissolving the marriage immediately, failing which my client shall be constrained to file appropriate legal proceedings against you in the Court of Law and in that event you shall be responsible for all costs, risks and responsibilities which you please note well.
9. A copy of this legal notice is retained in my office for record and further necessary action, if any.
